

2026 WPRA First Frontier Divisional Circuit Finals

The 2026 DC Finals to be held in conjunction with the Keystone Barrel Classic at the Keystone Horse Center in Bloomsburg, PA on November 14, 2026 at 11am EST.

Any card member who is in the Top 12 Divisional Circuit Standings can enter the Divisional Circuit Finals. If any of the Top 12 fail to enter (or positions open up), the next eligible person who entered will fill that position. Cut off for standings is September 30, 2026.

Must enter Saturday Open Race. All times from the WPRA DC Finals race will roll over to the Saturday Open race.

The Permit Race will follow the DC Finals Race (beginning at 11am EST).

This race is for permit holders for the 2026 and 2027 membership year. Money won will count toward filling your permit.

- Must enter Saturday Open Race. Time will rollover to the Open Race.

Awards to the top 5 who attend.

2026 Ground Rules
for Divisional Circuit Finals and Permit Race

1. Dress code in effect. Hat, boots, jeans and collared (button or zipped) shirt. Shirt must be tucked in.
2. Gate area must be kept clear.
3. Check in at the arena to let them know you are there to run.
4. Awards for Top 12 Divisional Circuit Qualifiers and Top 5 Permit to be presented immediately following the Permit Race. Must have paid circuit dues and participated in fundraisers.
5. **Must enter AND compete to get awards.** Entering another barrel race does not warrant an exception. The only exception granted will be if attending college out of state and cannot make it. A letter from the college must be forwarded to Chrissy at chrissy.chromczak@wpra.com
6. If you have a second horse you will be running in Saturday Open, please request to be an add on so you can be present for awards following the Permit Race. You must be present to accept your awards.
